

PET AREA REGULATIONS OF

THE "BAIA BLU BEACH" ESTABLISHMENT

Equipped beach area to allow access to people with dogs

- 1. Access to the area is limited to the opening hours of the Baia Blu Beach (from 10:00 to 18:00 from 1/06 to 7/06, and from 9/09; from 9:00 to 19:00 from 8/06 to 8/09).
- 2. The use of the PET AREA with the consequent use of an umbrella and two sun loungers, is permitted exclusively to those in possession of a regular fiscal receipt issued by the beach staff present at the Infopoint. This fiscal document must be kept until the end of the day and if requested, shown to the beach staff, such as Infopoint operators and lifeguards. Failure to provide the documentation and meet the above requirements will allow the authorized personnel to deny access
- 3. It is forbidden to bring dogs outside the path to reach the water area in front of the establishment, marked by the buoys.
- 4. Each dog may access if identified with a microchip or tattoo.
- 5. Owners are recommended, for the well-being of people and their animals, to subject them to the periodic vaccination prophylaxis against major infectious diseases (distemper, leptospirosis, and parvovirus), prophylaxis against major infestive diseases (parasites), and not to bring dogs with cardiovascular diseases to the beach.
- 6. Before accessing the beach, every individual must be equipped with a flea collar or equivalent; on the beach the dog must be kept on a leash, maximum 1.75 meters long, securely fixed to the ground, possibly to a stake firmly driven into the sand to prevent slipping.
- 7. The owner or caretaker must also carry a rigid or soft muzzle to be applied to the dog in case of risk to the safety of people or animals upon request of our internal staff or competent Authorities.
- 8. The owner or caretaker must ensure that the dog cannot reach nearby individuals; furthermore, they must also set up a bowl (available in the kit provided) with water always present and accessible to the animal, which must be given the opportunity to take shelter in the shade.
- 9. Any solid excrement must be removed and deposited in the appropriate waste container, while liquid excrement must be sprinkled and washed away with seawater, by the owner of the animal.
- 10. The establishment has fenced and marked showers for our four-legged friends.
- 11. The area designated for bathing dogs is included in the water area in front of the equipped beach area and is delimited with suitable and clearly visible floating equipment.

- 12. Access to the sea is allowed through a designated pathway; bathing is allowed for no more than 5 dogs at a time, which must be immediately reassured on a leash at the end of the swim; during the dogs' stay in the water, the presence of the owner must be ensured.
- 13. As far as possible, the owner or caretaker must avoid prolonged barking and excessively lively behaviour of their dog; otherwise, they will be required to move away from the beach. This faculty is also reserved for surveillance personnel, and access is prohibited to animals with aggressive syndrome and females in heat at their sole discretion.
- 14. Approximately every 2 hours, the owner or caretaker must lead the dog out of the beach for a walk.
- 15. The Infopoint determines which umbrella to assign and has the authority to make any movements deemed appropriate for the proper provision of the service. Each umbrella cannot be occupied by more than 3 people and 1 dog.
- 16. Dogs must never be left unattended and free to roam; the responsibility (civil and criminal) for damages caused by the animal lies with the owner. Our internal staff will monitor compliance with the rules.
- 17. The owner or caretaker fully and unconditionally assumes all civil and criminal liability related to and consequent upon the behaviour of their pet, hereby declaring to release the 'Baia Blu Beach' establishment from any responsibility, cost, expense, or compensatory measure it may incur for damages to persons and/or property directly or indirectly caused by their animal.
- 18. In case of non-compliance with this regulation, the offender must leave the establishment; furthermore, in the event of non-compliance with rules mandatory by law, the Management reserves the right to contact the competent administrative and health Authorities (Local Police and ULSS).
